Conditions of Tender:

1. Bidding will be conducted in line with the Provisions of Quotations method as contained in the Public Procurement & Disposal of Public Assets Act Cap 205 and Regulations 2023 and locally based tenderers are encouraged to apply.

2. All bidders shall be required to submit the following mandatory documents:

(i) Original receipt for non-refundable fees (On collection of bidding document).

Copy of National Identity Card. (Full; Front & Back)

Letter of recommendation from the LC 1 of bidder's residence or place of work.

- 3. Bid documents shall be obtained from the PDU Office Room 25 upon presentation of an ORIGINAL Non-refundable fees payment receipt which must be paid by Integrated Revenue Management System (IRAS), which must be obtained from the FINANCE OFFICE at the District Headquarters as under:
 - (i) 50,000/= for Revenue sources under Category A,

(ii) 25,000/= for Revenue sources under Category B,

4. Envelopes containing sealed bids must be addressed to **Head Procurement & Disposal Unit**, **P.O. Box 67. Masindi**.

5. Bids must be dropped in the bid box, in PDU-Offices No. 25 Upper block, District Headquarters and duly acknowledged for on or before **30**th **December 2025** at 10.00 am sharp. Late bids shall be rejected.

6. Bids will be opened in the presence of bidders who MUST attend in person at 10.30 am on Tuesday 30th December 2025 at 10:30am in the District Council

Chambers.

7. The highest/best bidder will be declared on the date of opening the bids and shall be required to pay the three (3) months deposit Upfront by IRAS ONLY within one (1) hour of declaration short of which, on the lapse of the accorded time, the Second higher bidder shall be allowed to pay up by 5:00pm (Close of Business Day).

Note: The sub counties and town councils' accountants shall <u>ONLY</u> generate PAYMENT REGISTRATION NUMBERS (PRNs) for the respective best evaluated bidders. And, the Finance Officer SHALL issue receipts to the successful bidders upon their remittances of the three (3) months upfront payment.

8. No Revenue Source SHALL BE awarded below the stated Reserve price. All quotations under the stated reserve shall be considered COUNTER OFFERS and

subsequently be rejected.
